

Frank Ion Tourism P.C. (doing business as Cool Car Rental) with Tax Registration No. 800928399 in Paros, Greece (hereinafter "the Company") has as main operation of Car Rentals and through its web site, www.coolcar.gr (hereinafter the "site"), under the following terms of use, which visitors / users are required to read carefully and visit / use of its pages / services, only if they are fully accepted. The use implies acceptance of these terms by marking the relevant field at the end of the text.

Visitors/users are responsible for accessing the site's services and paying fees to third parties (e.g. internet service providers, time of charge). They are also exclusively responsible for their personal equipment, with the necessary technological facilities that allow them access to its services.

As long as visitors/users wish to be subscribed to the site services, they agree to: (a) provide true, accurate, valid and complete information about the requested data of the relevant application form for access to its content / services; b) maintain and thoroughly update their subscription information to keep them true, accurate, valid, up-to-date and complete. c) receive promotional material and presentation of the site services. The company reserves the right to modify and / or suspend temporarily or permanently or suspend all or part of the site's services with or without notice to its users / members.

The site provides to the users the potential to be members and use their services. In order to do so, they must be registered by providing the following information compulsorily: Email address, first Name, last Name, gender, date of birth and to create their own unique password. The compilation of the above data is intended to measure the visits of the website, the creation of an account in www.coolcar.gr, the mass mailing of information and promotional material regarding with the Company's products and services, including its third-party partnerships and the maintenance of statistics and the improvement of information-provided services (e.g. personalized mailing of information material by gender), the recording of preferences regarding the site's services, and in general the users'/members' interaction with the site in full compliance with the applicable laws and regulations on the protection of individuals with regard to the processing of personal data and on the free commute of these data.

These personal data will be subject to processing by the company's customer service department.

The above data will be kept in Company's secure records for as long as it is in operation.

Each user / member has the right to submit an enquiry to the person who is in charge for access, or corruption, and / or deletion of personal data, or even a limitation of the processing that it concerns.

Each user / user has the right to object to the processing of its' personal data as well as the right to their portability.

Each user / member has the right to submit a complaint to the relevant supervisory authority, namely the Independent Data Protection Authority.

The company does not communicate to the third party any personal data of the site users /members without their prior consent.

The users/members comprehend and agree that the Company retains the exclusive right to discontinue the passwords on the site services and / or to discontinue the distribution of their content to users/members who believes that they have broken in the letter and spirit of these terms of use, informing the user / member in written for the termination and the reason (s) of it.

Except of the exceptions mentioned (third-party intellectual property, partner and entities), all the site's content, including images, graphics, photographs, designs, texts, services, and generally all the archives of this site, constitute intellectual property, filled marks and services marks of the Company and are protected by the relevant provisions of Greek law, European law and international conventions and treaties. Therefore, none of them can be constituted subject of sale, totally or partly, copied, modified, reproduced, republished or uploaded, transmitted or distributed in any way. Except of the case of the individual saving of one single copy, part of the content to a simple personal computer, for personal and non-public or commercial use and without the deletion of the indication of origin by the site, without affecting in no way the relevant intellectual and industrial property. The users/members understand and agree that they are not allowed to reproduce, copy, sell, resell and / or exploit in any way, the whole content of the site or partly.

Given the nature and volume of the internet, under any circumstances, including the case of negligence, the Company is not responsible for any kind of damage that visitors / users / users of the pages, services, choices and content of the site will be gone through to which they proceed by their own initiative. The contents of the site are provided "as is" without any warranty expressed or implied in any way. To the fullest rate and in accordance with the law, the Company denies all expressed or implied warranties, including, but not limited to it, those that are implied the merchantability and adequacy for a particular purpose.

The Company does not warrant that the pages, services, options and contents will be provided without interruption, without errors and that the errors will be corrected. Also, it does not warrant that the site or any other site or servers through which they are available to users / members, do not contain viruses or other harmful components. User's Registration

The User's registration on www.coolcar.gr is optional. Each user is registered only once. By using the user the unique combination of e-mail address and password that he has chosen and registered, he has the following capabilities:

The registration and participation of the user is free of charge, personal, non-transferable and unassigned. The user is responsible for the information he provides to the Company and the website is exclusively based on his / her statements regarding his or her personal data. The data that is registered must be complete, verified and up-to-date. If a legal person is registered as a user, the name of the contact person as well as the full name of the legal person must be stated. In case of data changes, the user is obliged to inform immediately for his / her new data in www.coolcar.gr so that to be always complete and true.

The personal data that the user grants upon his / her consent during his/her registration, the Company processes them with his/her consent in order to (a) create an account at www.coolcar.gr (b) to send him informative, advertising and promotional material regarding the Company's products and services, including its partnerships with third parties.

Regarding the compilation and the processing of the personal data, the terms and conditions for the protection of individuals that apply as per current legislation, are against the processing of personal data and the free release of them.

By registering in accordance with the foregoing, the user gives his exclusive consent and agrees with the compilation and processing of his data under the current terms of use and the relevant current legislation for the protection of individuals against to the processing of personal data and the their free release for which he/she registers that he/she has read, understood and unconditionally accepted. Any time, he has the right to withdraw its consent for the collection and processing of personal data it has provided in accordance with the above, applying editing as user by sending an e-mail to contact@coolcar.gr. He has the access to his data, or he may also request the immediate editing or correction of the data, at any time, he can ask for a temporary non-use in www.coolcar.gr, the commitment or non-transmission by following the above same procedure of email transmission. Personal data do not announced to any third party and is managed exclusively by the company and only for specific purposes.

Newsletters

The newsletters that the visitor / user of the site services receives by registering them in the mailing lists, are intellectual property of the Company and are, therefore, protected by the relevant provisions of Greek law and the international conventions. The Company reserves the right not to register a person to the mailing lists or to delete them from them. The Company has the right to keep a record with the e-mail addresses of the recipients for the mailing and other informative or financial messages besides the newsletters, but always with the user's consent, which is provided by registering in the site.

The www.coolcar.gr, is not responsible if the newsletters do not deliver to their destination, although it makes every effort to deliver their ISPs (Internet Service Providers). The newsletters may end up in the "Spam" folder. In case the user wishes not to receive newsletters any longer or wishes to be totally editing from the site newsletter system, he may notify the Company using the site's contact form or through the link that appears in the newsletters he receives.

The website uses a provider to track the newsletter recipients. It does not provide information to third parties regarding their name, surname, address or other personal data.

Use cookies

Cookie is a small piece of data which is sent to the client's browser from a web server and stored in the user's hard disk. Cookies do not cause damage to the client's computer system and do not affect its functionality. Cookies also make the web browsing easier for the user by saving their settings. The site uses cookies to provide specialized services and content that covers the user's interests. The above cookies do not contain personal identifiable information.

Most browsers automatically accept cookies, but the user has usually the capability to set up his browser to prevent them. Even without a cookie, the user can use most e-shop services.

Cookies Analytics:
